Leadership Experience

I lead an applied research and Extension program focused on diseases of fruits and vegetable crops, with emphasis on viruses and virus-like agents, and provide leadership and coordination for Extension education in plant disease diagnosis and management for South Texas. I have been a member of APS since 2007 and a member

of the APS Pacific Division (2007–2012) and am currently a member of the APS Southern Division (since 2013). I am also a founding member of the APS African Division (APS-AD) and served as its inaugural president (2022–2023) after its creation. I served as the immediate past chair of the APS Virology Committee (2023–2024) and am currently a member of four other subject matter committees. Besides committee service, I currently serve as a senior editor for Phytopathology (2024-to date) and previously served as an associate editor (2016-2017) and senior editor (2017-2021) for Plant.Disease. I am an advisory board member of the journal Archives.of. Virology (2021-to date) and an associate editor for the journal Phytoparasitica.(2023–to date). I am also a member of the Technical Advisory Committee of the Texas Citrus Pest & Disease Management Corporation, the Outreach & Extension Committee of the National Clean Plant Program, the Steering Committee of the Emerging Viruses in Cucurbits Working Group, and the International Council for the Study of Viruses and Virus-like Diseases of the Grapevine (ICVG). In these roles, I contribute my expertise to advance the science of plant pathology and ensure that APS remains globally relevant and responsive to issues relating to plant health. I strongly believe in the concept of servant leadership and view my leadership role as helping the group to achieve its goals, while ensuring that future leaders are identified and effectively mentored to tackle future plant health challenges. My willingness to volunteer in various capacities within APS stems from my resolve to give back to the society that has helped shaped my career as a plant pathologist.

Statement of Vision for APS

One of the most rewarding aspects of my career as a plant pathologist is my membership in APS. As a student and, subsequently, a regular member of APS, I owe my career progress to the opportunities provided to me by the society to network with a global community of

plant pathologists. Such opportunities include formal and informal leadership training, avenues to present my research to my peers and receive invaluable feedback from the community of experts, enriching educational programs, development of skills in program development and delivery, professional skills development, career advising, mentorship of local and international students, collaborative endeavors, and serving on grant review panels and expert groups.
