Editorial Policies

PLANT DISEASE is an official monthly publication of The American Phytopathological Society. This international journal of applied plant pathology publishes original research articles; reports of new diseases and epidemics; feature articles on needs, approaches, and accomplishments; and exchanges of news, ideas, and opinions. All opinions, editorials, and papers published in PLANT DISEASE reflect the views of the authors and are not necessarily the views of the Society or of the institutions with which the authors are affiliated. The Editorial Board reserves the right to reject or accept letters for publication and to edit letters for clarity and conciseness.

Submission of manuscripts: Manuscripts should be mailed to PLANT DISEASE, The American Phytopathological Society, 3340 Pilot Knob Road, St. Paul, MN 55121. Manuscripts should not be submitted to the Editor-in-Chief. Submission implies nonsubmission elsewhere and, if the manuscript is accepted, no publication elsewhere in the same form without consent. Manuscripts from nonmembers as well as from members of the Society will be considered for publication.

Page charges: Because of the high cost of publishing articles in PLANT DISEASE, a charge of \$55 per printed page is mandatory. A letter confirming that the author or the author's institution, company, or research sponsor will honor the page charges must accompany each manuscript submitted.

Separates: Reprints of articles or free copies of PLANT DISEASE are not supplied. After publication, the negatives of each article are mailed to the author for reprint purposes; negatives should not be returned to PLANT DISEASE.

Use of material: PLANT DISEASE is copyrighted, and anyone wishing to use data or illustrations appearing in this journal in another publication must obtain permission from The American Phytopathological Society and the author(s) of the paper and provide a line crediting PLANT DISEASE as the source. The appearance of the code at the bottom of the first page of each article indicates that—except where direct copying licenses have been granted by the copyright owner—the copyright owner requires the user to pay the stated per-copy fee through the Copyright Clearance Center, Inc., 19th Floor, One Park Avenue, New York, NY 10016, for any copying beyond that permitted under Sections 107 and 108 of the U.S. Copyright Law.

Instructions to Authors

General. Submit the original and two copies of the manuscript on 8½ × 11 in. (216 × 279 mm) line-numbered paper and three sets of each figure. All material must be typed double-spaced: title, by-line, abstract, text, literature cited, tables, and figure legends. In the upper right corner of each page, type PLANT DISEASE, the author(s) name(s), and the page number. Number the pages consecutively; literature cited follows the text, then tables (each on a separate page), and figure legends.

Format. Consult the "Research" and "New Diseases and Epidemics" sections of this issue for arrangement of heads and subheads, use of capital letters, indents, etc.

Title. The title should reflect the important aspects of the article and be as concise as possible.

By-line. The author(s) name(s) should be followed by affiliations and complete addresses. Acknowledgments should be at the end of the text, preceding literature cited.

Abstract. Solid lines should separate the by-line material from the abstract and the abstract from the text. The complete citation for the article should appear between the word "ABSTRACT" and the text of the abstract. The abstract should be as brief as possible—100 words or less for "Research" articles and 50 words or less for "New Diseases and Epidemics" articles. Content should be limited to major findings and conclusions.

Additional key words, if provided, should appear in the text but *not* in the title or the abstract and should be listed in alphabetic order.

Text. The major sections after the introductory statements are MATERIALS AND METHODS, RESULTS, and DISCUSSION; RESULTS and DISCUSSION may be combined, if desired. Subheads may be used, but excessive fragmentation of the text should be avoided. Footnotes are not permitted. Tables and figures should be cited in numerical order.

Tables. Titles should be self-explanatory and include enough information so that each table is intelligible without reference to the text or another table. Information presented in a table must agree with that in the text. Nonessential details should be omitted. Numbers should be rounded off to significant digits, and ditto marks should not be used. Abbreviations are acceptable; nonstandard ones can be explained in footnotes. Footnotes are designated with superscript lowercase letters.

Figures. Illustrations must be originals and of high quality. Glossy prints should be clear and cropped at right angles to show only essential details. A 1:1 (same-size) reproduction is preferred, particularly for electron micrographs. The exact width for same-size reproductions is: one column—55 mm (2 3/16 in.); two columns—117 mm (4 5/8 in.); three columns—178 mm (7 in.). The maximum depth, including figure caption, is 250 mm (10 in.). A scale bar should be included on the photo. Composite photographs should be mounted on hard cardboard, with the edges in contact (thin spaces will be inserted between photographs during processing). Composites should be matched for similarity of contrast, background density, and content; line drawings and photographs should not be combined. Line drawings should be made by a competent draftsman and be either originals or glossy prints. Ordinates and abscissas should be marked with index lines. Same-size line drawings can be keylined directly, saving time, labor, and

production costs. Numbers and lettering (upper and lower case) on same-size illustrations should be in 10 pt Universe 55, except figure designations (A, B, C, etc.), which should be capital letters in 18 pt Universe 55; the lettering is available in art supply stores. Prints with poor alignments, blurred lines, or out-of-focus letters and symbols will not be accepted.

Each illustration should be labeled with the figure number, author's name, and PLANT DISEASE. Figure captions should be fully descriptive so that the illustrations are understandable when considered apart from the text.

If color illustrations are submitted, transparencies or glossy prints should be included with the manuscript. A cost quotation will be provided, and the author or an institutional officer must formally indicate acceptance of the quoted rate before processing will be started.

Literature cited. All references listed must be cited in the text and must be accurate and complete. List in alphabetic order by authors' surnames. When citing multiple works by the same author, list single-authorship articles before those by several authors. Determine the sequence by alphabetizing the first author's surname and junior authors' surnames, by the year of publication (most recent last), and, if necessary, by the page numbers of articles published in the same journal. Underline Latin binomials. Capitalize all German nouns, and insert diacritical marks. List total pages of theses and bulletins and specific pages of books. Refer to *Chemical Abstracts Service Source Index* for journal abbreviations. An example of a journal citation is: Bonman, J. M., Delwiche, P. A., Gabrielson, R. L., and Williams, P. H. 1980. *Leptosphaeria maculans* on cabbage in Wisconsin. *Plant Dis.* 64:326. An example of a book citation is: Barres, H. D. 1968. Determination of water deficits in plant tissues. Pages 235-268 in: T. T. Jones, ed. *Water Deficits and Plant Growth*. Vol. II. Academic Press, New York. 333 pp.

Do not list a work that is in preparation, submitted but not accepted for publication, accepted but not published, or not available in libraries. Cite the work parenthetically in the text: (J. Jones, *unpublished*) or (J. Jones, *personal communication*). Written permission from the person(s) cited as the source of unpublished information must be provided when the manuscript is submitted.

Editorial style. After acceptance for publication, manuscripts are edited for style, grammar, clarity of presentation, and preciseness and conciseness of statements. Preferred spellings are according to *Webster's Dictionary*. Helpful reference books are *Council of Biology Editors Style Manual* (4th ed., American Institute of Biological Sciences, 1978) and *Handbook for Authors of Papers in American Chemical Society Publications*.

The metric system is preferred. Use numerals before standard units of measurement, eg, 1 g, 9 hr; otherwise use words for numbers one through nine and numerals for larger numbers. Nonstandard abbreviations that facilitate comprehension may be used; at the first use, spell out the term and enclose the abbreviation in parentheses. Words to be italicized should be underlined. A fungicide should be listed by the approved common name; the chemical name is used only if a common name is not available. Ambiguous characters—eg, the letter O and the number 0, a prime sign and an apostrophe, the letter l and the number 1, the multiplication symbol × and the letter X—should be clearly identified in the left margin of the text.
