## Editorial Policies

**PLANT DISEASE** is an official monthly publication of The American Phytopathological Society. This international journal of applied plant pathology publishes original research articles; reports of new diseases and epidemics; feature articles on needs, approaches, and accomplishments; and exchanges of news, ideas, and opinions. All opinions, editorials, and papers published in **PLANT DISEASE** reflect the views of the authors and are not necessarily the views of the Society or of the institutions with which the authors are affiliated. The Editorial Board reserves the right to reject or accept letters for publication and to edit letters for clarity and conciseness.

**Submission of manuscripts:** Manuscripts for the Research, New Diseases and Epidemics, and Disease Notes sections should be mailed to Editorial Office, **PLANT DISEASE**, The American Phytopathological Society, 3340 Pilot Knob Road, St. Paul, MN 55121. Manuscripts should not be submitted to the Editor-in-Chief. Submission implies nonsubmission elsewhere and, if the manuscript is accepted, no publication elsewhere in the same form without consent. Manuscripts from nonmembers as well as from members of the Society will be considered for publication.

Inquiries concerning sections of the journal may be directed to the person in charge of the section: Disease Notes, Editorials, Letters, New Diseases and Epidemics, Research, and special topics, W. **Page charges:** Because of the high cost of publishing articles in **PLANT DISEASE**, payment of page charges is mandatory. Page charges are subject to change and will not be finalized until the author receives galley proofs. Current charges are \$90 per printed page for members of The American Phytopathological Society and \$155 per printed page for nonmembers. The author is billed after the article is printed in the journal. A letter confirming that the author or the author's institution, company, or research sponsor will honor the page charges must accompany each manuscript submitted. Authors who submit manuscripts satisfactorily prepared for electronic processing will receive a decrease of \$25 per printed page.

**Illustrations:** By special arrangement for illustrations in which detail is extremely important, high-quality photographs can be printed on glossy paper. Requests for this special printing must be made when the article is submitted; costs for the extra handling will be determined on an individual basis.

**Separates:** No free copies are supplied. Reprints are available to authors; an estimate of cost is sent with proofs. Orders for reprints must be received within the year after publication of an article.

**Use of material:** **PLANT DISEASE** is copyrighted, and anyone wishing to use data or illustrations appearing in this journal in another publication must obtain permission from The American Phytopathological Society and the author(s) of the paper and provide a line crediting **PLANT DISEASE** as the source.
